Your Price Protection gallons are now available for purchase!

The PPC is a way to purchase propane at a fixed price per gallon. This option will provide you with price security without the cash outlay needed to purchase gallons up front. By submitting a non-refundable \$50.00 contract origination fee you will receive the PPC price listed on the contract from the contract date until April 15, 2020. Your price per gallon will be locked in at the PPC rate until the expiration date. Each PPC contract covers a maximum of 1000 gallons.

No additional discounts will apply to the PPC. Standard payment terms will apply. Minimum delivery amounts are required for each delivery. Any requested deliveries that are less than the minimum requirement will be priced per gallon at the prevailing market rate at the time your order is placed.

If you would like to have your propane gallons at a fixed rate for the upcoming heating season, simply detach the bottom portion of this letter, choose your method of payment, sign the form and return it to our office with your \$50.00 payment by the expiration date listed at the bottom of this letter.
